  - Add additional cookie judge and line per age division due to high volume of exhibitors.
  - Creative Crafts – Break Junior Division into two groups due to high volume. Award one trophy for 8/9 year olds and one trophy for 10/11 year olds.
  - Martha moved to accept Kristi recommendations, Larry second. Motion carried.
